

## How to Re-Pull Frozen or Locked Bureaus On-Line

1. Start by logging into Credit Plus Inc and opening your borrowers file from the main page.



2. First, please notice the file number of this report. When frozen files are added, the data is copied to a new file number no longer showing the frozen submissions. Now, to add the frozen bureaus to the credit file, under ADD-ON PRODUCTS click **Reorder Frozen/Locked Files**.
